## CHEROKEE NATION TAX COMMISSION MEETING SEPTEMBER 11, 2024 4:30 PM

**Roll Call:** Chairman Wilson

**Commission Present:** Chairman Wilson, Commissioner Robinson, and Commissioner Doublehead was present.

**Staff Present:** Sharon Swepston, Chelsea Fisher, Shelia Sawney, Teresa Carder, Tammy Guinn (telephone), and Fonda Gritts.

**Visitors Present:** Paiten Qualls, Attorney General's Office.

Meeting called to order by Chairman Wilson at 4:30. Quorum was established with Chairman Wilson, Chairman Fan Robinson, and Michael Doublehead.

**The Commission began with agenda #1 – Approval of Minutes for June 12, 2024** – Commissioner Robinson stated in agenda item #3 needs to read “Shelia Sawney states” instead of “She states”. With that amendment being made Commissioner Robinson made a motion to approve the amendment. Commissioner Doublehead seconded the motion. Motion carried.

Commissioner Robinson made a motion to approve the minutes with the amendment. Commissioner Doublehead second the motion. Motion carried.

***Agenda item #2 - Stephenson Wholesale Co., Inc. /DBA/ Indian Nation Wholesale (2)*** – Stephenson Wholesale bought out Standard Distributing and Stephenson have turned in all the document that is required. They changed the name to “Indian Nations Wholesales”. Shelia recommends approval.

Commission Robinson made a motion to approve the Wholesale license. Commissioner Doublehead seconded the motion. Motion carried.

***Agenda item #3 – Rules and Regulations Definitions – M.V. 01-1-210.3 –Replacement for Undelivered Tag-Decal-*** Tammy Guinn stated we need to make a change from 14 days to 21 days. We are receiving quite a bit of request for undelivered decal and tags. It is taking at least 21 days for the customers to receive their decals and tags. She explain the sort center in Tulsa has been moved to Oklahoma City. By the time the mail is leaving the post office it has been taking more than 14 days. This also is for renewals or anything that we put in the mail. Tammy recommends that we need to change the days to 21 days.

Teresa Carder stated if the customers does not receive it they can file for us to replace it for free. Sharon said they are requesting an undelivered and we are sending them a new tag and before we can get that one out to them before they receive it they have received the first one. And it has already been voided, so then they have to wait for the second one to arrive.

Commissioner Robinson made a motion to approve the days from 14 to 21. Commissioner Doublehead seconded the motion. Motion carried.

***Agenda item #4 – Monthly Reports*** – Sharon Swepston stated Motor Vehicle is almost 1% year to date we are running just about the same as last year at this time.

On Revenue and Taxation we are running about the same as Motor Vehicle. The month to month floats, but we are about the same as last year.

The new “Mason Treat” legislation may cause us to see some fluctuation. People may be confused but we are trying to answer any questions customers may have about it.

Commissioner Robinson ask, are we trying to follow the State? Sharon stated we are trying to make sure our citizen know they do not have to complete a registration with the State. Just because they are given a temporary registration they can still come to us once they receive their paperwork to register their vehicle just like they always have.

Commissioner Doublehead made a motion to approve the monthly reports. Commissioner Robinson second the motion. Motion carried.

***Agenda item #5 – Consideration, discussion, and possible approval regarding any matter not know about or which could not have reasonably been foreseen prior to the time of posting.***

Sharon has an update on the Veterans Military tags. We have received approval to use all but the Navy. She said we explain to them and they sent us something back stating the language would be okay. Tammy Guinn sent them some information on how we are doing it here and they were fine with that. Sharon sent that to Administration and when it gets sign we will be able to move forward. Sharon passed out some samples of the tags that Tammy put together. They will need to go to art department at Oklahoma Correctional Industries and they will do some designs for samples to be made. And then they will go for approval to Administration.

Sharon will email them to the Commission to look at first and they can make a recommendation to Administration.

Commissioner Robinson stated she has a discussion for the record. In the Chief State of the Nation Address, he mention the tag compact. She said weather the Governor signs it or not we will continue to sell tags on the reservation. Commissioner Robinson said that brings up a red flag to her. If the citizens travel out of jurisdiction will they be getting stopped?

Paiten stated there is always a chance of that happening, but she doesn't think that will. She said she is hopeful that we are in a place with law enforcement that we have all the MOU's with the counties and they move freely between that. We have a good working relationship with them. So she is hopeful they would continue to work with us. Preserving public safety and not harassing tribal citizens. Paiten said she could get the commission a firmer answer later. And analyze what the right of action would be.

Sharon had one thing to add. Shelia wanted to make note on the Wholesale license that was approved, there was two license and not just one license. They have two locations.

It was Indian Nation #1 and Indian Nation #2. We need a motion to approve the Indian Nation #2.

Commissioner Robinson made a motion to approve the Indian Nation #2. Commissioner Doublehead seconded the motion. Motion carried.
