

Worked with John and Nick (IT) on the storage issue on Chronical, the backups are running long because of all the images that it is have to go through. We have discussed the possibilities of other storage locations on site. We have not come up with a solution yet.

Simon came to the office for the acceptance testing and the scanners all passed, 9 of the ballot boxes did not pass and they were picked up and we will receive 9 new ones. Ordered the shelves for the ballot boxes and they were assembled by Facilities and all is looking good. Simon will be back in August for the training on the new system. One of the towers was setup wrong so it was sent back to be reimaged and will return soon. We will receive two printers, towners, and 10 additional V-drives. We currently have a credit at Hart and the additional equipment will come from that credit. We will still have a credit with Hart after the additional equipment is subtracted.

We had adobe pro put on my computer to work on the PDF's of the election manual updates. I have completed the first edits of the Election Day Desk Reference, and the Precinct Official Manual. Will go back through them again and do more editing before I send you the proofs.
