Below are the 4 suggestions that were discussed in the Policies and Procedures work session yesterday.

- 1. Setting the Election for the third Saturday instead of the second. Section 51.B
- 2. Striking the part that says "consecutive" and striking "commencing on Tuesday and ending on Thursday" in section 62.D (4th of July will fall on one of the early walk-in days required by the Act.)
- 3. Change the AB request deadline from the "Second Monday" to the "Fourth business day" Section 73.B and changing the AB mail out dates from the 19-20 to the 22-23.
- 4. Supreme Court to make a decision in 3 days instead of having a possible 6 days. Section 101.E Hopefully this helps.
