ENROLLMENT PROCESS

All applications (including Public Schools) will be screened and entered into ChildPlus upon receipt by the Main Office. Eligibility will be determined using the eligibility points which have been pre-entered into ChildPlus. Categorically eligible (*) families will have points automatically applied based on guidelines & information from the application. Any other applicable guidelines listed under Eligibility Criteria and the Over Income Scale will be applied manually. The Over Income Scale will be used to deduct points based only if a family exceeds the Poverty Guidelines. Points for Tribal Citizenship will be applied to those applicants presenting a Tribal Citizenship Card for the child or parent from the Cherokee Nation or any Federally Recognized Tribe. Final income approval will be made by the designated Enrollment Specialist or their back up. ChildPlus will prioritize applications for enrollment based on the number of points & date received.

****Early Head Start students are in the program for 3 years, however Transition FROM Early Head Start to Head Start requires a new application****
