CHEROKEE NATION GAMING COMMISSION MEETING MINUTES 06 May 2022

I. CALL TO ORDER:

Chairman Sparks called the meeting to order at 9:40 A.M.

II. ROLL CALL:

Mikal Yahola called Roll.

Five (5) commissioners were present and a quorum was established.

III. APPROVAL OF AGENDA:

Chairman Sparks, the first item on the agenda is the approval of the agenda. Commissioner McGeady motions to approve the agenda; seconded by Commissioner O'Leary. Motion carried.

IV. APPROVAL OF MINUTES:

Chairman Sparks, the next item on the agenda is the approval of the Minutes as they've been distributed.

The reports under item VI. A., B., C., and D. were received in Executive Session and no action was taken. Commissioner DeLozier motioned to exit Executive Session; Seconded by Commissioner Hull. Motion carried and the Commission exited Executive Session at 10:38 A.M.

VII. OLD BUSINESS

The Chair asked if anyone would like to be recognized for anything pertaining to Old Business. Executive Director Purcell asked and was recognized. She then stated that the Vendor Licensing Regulation is posted today (06 May 2022) and that there will be a thirty (30) day comment period. The commission received the information and no action was taken.

VIII. NEW BUSINESS

A. PERMITS & LICENSES – F. NORTHINGTON
