# CHEROKEE NATION GAMING COMMISSION AMENDED MEETING MINUTES 29 July 2022

### I. CALL TO ORDER:

Vice-Chairwoman McGeady called the meeting to order at 9:45 AM.

#### II. ROLL CALL:

# III. APPROVAL OF AGENDA:

### IV. APPROVAL OF MINUTES:
