CNGC Tribal Internal Control Standards (TICS) require an annual review of gaming promotions and program controls. The design and implementation of management's controls was satisfactory to aid in the compliance with regulatory requirements. For this audit they presented no findings. The Chair recognized the information is provided and received. No objections.

# H. TICS COMPLIMENTARIES REVIEW-INFORMATION ONLY - A. Imhoff

The Chair recognized A. Imhoff. Ms. Imhoff reported the Complimentaries review. CNB Audit identified a minor issue regarding TICS 16.1G that did not adversely affect the systems of internal control.
